

**Minutes of the Annual General Meeting of Haddiscoe Parish Council held on Monday 7<sup>th</sup> June 2021 7.30pm at The Hollies, Low Road, Haddiscoe.**

**Minutes of the Last Meeting:** Minutes of the combined Ordinary & Annual Public Assembly Meetings held on Monday 19th April 2021 were read through and agreed by all present.

**Matters Arising from the Minutes:** The clerk was asked to investigate whether The Crown planning application for the two holiday lets had been approved.

**Election of Chairman:** Mr Haycock will continue as Chairman and Ray as Vice Chairman. Both were voted in by all present.

**Planning:** Ref: 2021/1192 – Erection of steel building at Hillfield Nurseries, Mill Lane – The PC approved this application. It is noted that Mr Beevor (absent) will have to declare an interest in this application.

Ref: BA/2021/0065/HOUSEH – Seven Mile House – Extension and conversion of outbuildings – PC approved.

**Finance & Administration**

The clerk was asked to raise a cheque for £60.00 for The Haddiscoe Charity.

**Speed Monitor:** This is now on Thorpe Road. In the foreseeable future, we may need to purchase new batteries as the current ones are coming to the end of their lives.

**Playground:** Mr Long reported that everything seems fine at the playground.

**Highways:** Mr Fulcher informed us that the road drain outside his house (Firkin Hall, The Street) has collapsed. It is constantly flooded and smells. It has been reported but the clerk was asked to follow this up on behalf of the Parish Council.

**A.O.B:** The Haddiscoe Parish Council needs to recommend someone to the Haddiscoe Charity to act as a trustee.

The next meeting will be held at The Hollies again on Monday 16<sup>th</sup> August 2021 – 7.30pm

It was reported that a burglary took place at Maypole in Toft Monks and the contents were found on Haddiscoe marshes. Several complaints were received from a parishioner – overgrown hedges, positioning of the dog poo bin on Church Lane, PC not following up parishioners' complaints, speeding along the A143, dog mess on private land and footpaths, Church Lane signage. All complaints were made by one parishioner. Mr Haycock responded accordingly via email on 14<sup>th</sup> April 2021.
